POP Climate Committee - Draft Statement for the Port of The Dalles Wednesday September 15, 9:00 am

Members of the Port Commission,

Thank you for the opportunity for citizens to share their concerns. Today I'm speaking on behalf of a local group of citizens, called Protect Oregon's Progress and other residents who are concerned by the impacts of global warming.

We are here this evening to ask the Port Commission to take seriously the threat climate change poses – including drought, fires, disease, displacement, and severe and erratic weather. Your actions now have the potential to affect our community for decades to come. As you plan for the future, we ask that you look at things through a lens of climate change. The time for debating whether or not this is "real" is over. Climate change is upon us. Now it's time for all leaders to take action.

We see three major questions that we all should be asking ourselves as we make decisions going forward:

- How can we mitigate the impacts of climate change?
- How can we adapt to the impacts of climate change?
- What can we do to reduce our greenhouse gas emissions?

Obviously, answers to these questions deserve much more thought and discussion than we have time for tonight. We hope this is just the beginning.

It is essential to acknowledge that there is a cost to act, but also a cost to not act.

Consider, for example, that a third of U.S. residents live in a county that was struck by a climate-fueled disaster just in the <u>last three months</u>. Many of those events set new records and led to billions of dollars in damages. Locally, I think it's safe to say most of us don't want more record heat waves like we had this past summer. Globally, the <u>newest report</u> by the Intergovernmental Panel on Climate Change informs us that the planet is entering the hottest period in the last 125,000 years.

Several of our neighboring communities are way ahead of us on this front, which is good news for us – we can learn from their experiences. This is certainly not something our community has to figure out on its own.

We want to emphasize that this is an *opportunity* for our community - an opportunity to be leaders in a changing economy, to establish local renewable sources of energy to keep costs down, and to work together toward a more livable future. We urge you to begin this planning, along with the various city councils in the county, the Wasco County Board of Commissioners, and other local stakeholders, to start building a healthier, more vibrant, more resilient community for us all.

<u>Items completed this quarter</u>

- ➤ Algae spread through the Marina and arranged for the Public Side also.
- Fire Extinguisher test completed through out the Marina.
- Meeting with Yacht Club
 - o Events
 - o Grant for Fuel Tank
- ➤ Temp Fence and Lock installed at Marina at the end of D Finger for no entry.
- ➤ Had diving service out to Level C Finger. After the fire on D finger, the docks were off level due to losing floats under the walkways.
- ➤ Had Sealkote restripe and clean parking lot.
- Algae was very bad at the Marina this year. We spent hours trying manually remove throughout the Marina. We had a catcher built on the front of the boat to be able to grab the algae and remove it. It worked wonderful! We maintained the private side along with the public side.
- ➤ Had plumbers and divers out to work on water system. Break in main water line under the dock for A finger.
- ➤ Had one garbage can removed and down to one garbage can for the winter.
- Backflow test completed for the water system.
- ➤ Maintenance completed for the security system. Replaced one failed camera.
- Major repair on garbage can structures due to Vandalism.

Projects in Progress

- Winterize Marina.
 - Pull up hoses
 - o Insulate the mains.
 - Blow out on top of the dock water system
- Landscaping to be trimmed and pull out flowers from the summer
- ➤ Working with Hage Electric to come out and do maintenance on the electrical system. Hage Electric is on a job currently, so I am waiting for a date that they can come out.
- ➤ Currently working on doing a new budget. Due to the fire loss, the Marina will lose 8 boathouse revenue and 12 boat revenue. The expenses will stay the same at the Marina.

What's going on at the Marina

- ➤ 1 Boathouse for sale at the Marina. It is currently located on A finger.
- ➤ Meetings with Marina Tenants with loss from the fire. Met with Contractor at the Marina to try to coordinate clean-up.
- ➤ Continuing meetings with the Yacht Club. They had a small poker tournament last month and are planning their annual Halloween Party. They are constantly strategizing on doing small events that would work with Covid. Since the fire, The Yacht Club has been used excessively by US Ecology. Many of us have been donating our time to keep the Yacht Club clean during this time.

Not only with the fire at the Marina this summer, we had a huge influx of homeless issues. We have dealt with theft, vandalism and people getting behind the gate. We have been able to make 2 arrest with the strong monitoring that we currently do. Mental Health issues are a continuing issue that we have in the City of The Dalles and we will continue to work at keeping the Marina safe and free from this. We are currently having issues with one Marina Tenant that has not been following Marina Rules and they have been put on notice. We also have another issue with an open investigation. Besides the couple of issues, we have great tenants that are very caring, kind and always looking out for each other.

Executive Director Klaas

Update: Fire at The Dalles Marina

- ➤ Cleanup of the fire started Monday, October 11th and is expected to be done by Friday, October 15th. NW Maritime Consultants is the project manager onsite for the Port. Associated Underwater Services (AUS) is the contracted company handling the environmental cleanup and vessel salvages in cooperation with HME who provide the tugboat and materials barge. US Ecology removed its boom containments, and they were replaced with booms from AUS for the duration of the cleanup. *Photos following taken on 10/11/2021
- ➤ There will be a time lapsed video of the cleanup that we will share once we are done.
- ➤ There are still many things to work through, and this event has been consuming a lot of Port staff time; our time is being tracked and we will see if any of it can be recouped once we are done.
- ➤ The Port will start submitting reimbursement requests to the Oil Liability Trust Fund next week. This will include the cost of US Ecology to clean up and manage the spill, Port staff time directly related to the event, lost revenue from D Dock, and The Dalles Marina, LLC time regarding this event. We will be submitting several requests over the next month or so.

Columbia River Gorge Commission (CRGC)

➤ No specific update this month. The attorneys did meet, and there is another meeting Tuesday, October12th. I anticipate I will have a full report for November.

Port of The Dalles Marina

- The Launch Ramp restrooms continue to be open.
- ➤ Roto-Rooter has looked at the problem sewer line and given us an estimate of about \$6,000 to do the repair. Oregon State Marine Board (OSMB) may have emergency funds available for this. It is something that we need to address soon, so if there are no OSMB funds, the Port will be paying for this too.
- ➤ Pikeminnow fishing season is still underway, it was extended through October 17th.
- ➤ One boat that was displaced from the fire is still berthed in the Transient Guest Moorage. The Dalles Marina, LLC is working on making space available for it to move back into. Unfortunately, the Sea Scouts vessel the SS Freedom could not be accommodated at the marina due to its size, so it went upriver to Arlington with hopes that when the D Finger is rebuilt it will find a home here in The Dalles again.

Trees Cut on Port Property along Riverfront Trail

- ➤ Matthew Ellis, DA criminally charged Anthony Morelli for this; we will have an update of that proceeding for the meeting.
- Wasco County Soil and Water Conservation District developed a list of recommended trees and plantings for the damaged area.
- A local landscaper is developing a cost estimate to replant the site with good soil, mature trees, and irrigation so they get established. Once we have this in hand we can pursue treble damages, including Port staff time, and legal costs, if any.

General

- ➤ The annual audit has been reviewed and will be finalized shortly. We will be scheduling time for the audit presentation. Copies of the audit will be sent out to the Commissioners prior to the meeting for review.
- ➤ Mid-Columbia Economic Development District (MCEDD) hosted the seventh and final meeting as part of the Columbia River Gorge Regional Economic Development Strategy (CEDS) update. This meeting focused on goals and strategies. Once the document is complete Port staff will share it with the Commission.
- MCEDD will be holding their Columbia Gorge Annual Economic Symposium Friday, November 5th. It will be held virtually, if you would like more information, please let ED Toepke know.
- ➤ Center on Rural Innovation (CORI) team met to continue the Federal funding discussion. The local group will be meeting with Google to present our findings to them and see if there is a role for Google to play supporting tech entrepreneurship.
- ➤ ED Klaas met with Mayor Mays to discuss ways the Port and City can combine forces and work together. The City of The Dalles and Wasco County will have additional financial resources, that may be available for projects, as part of the Federal stimuli package that came to Cities and Counties.
- ➤ Some ongoing items: Personal policy handbook is being updated to meet new legislative requirements; review of the City of The Dalles Camping policy and is it applicable to Port property; as noted above, application to Oil Pollution Liability Trust Fund; Oregon State Marine Board Grant; Special Districts Safety & Security Grant
