#### PORT CALENDAR/EVENTS

Andrea Klaas reviewed the calendars for September and October 2013.

#### **VISITOR'S BUSINESS**

Jeff Renard, Steve Sweitzer and Jennifer Staver asked for discussion on proposed Marina water system. Concerns: Tenants had no previous notice of new water system; what was the process to get the design/bid for the proposed system; paying for boathouse moorage but not having water for 5 months. Commissioner McFadden outlined the conditions from the City of The Dalles to forgive the high water usage bill in May with the understanding a new water system would be installed within 120 days. Commissioner Courtney asked if the winter water used would be willing to pay for a year-round water system. Steve Sweitzer stated he was willing to pay \$100,000 towards a new year-round water system and felt there were 21 other boathouse owners who would be willing to pay also. He will get the names of those boathouse owners to the Port. Commissioner McCavic stated as a boathouse owner she did not want to pay for a year-round water system but felt there should be more input from the boathouse owners. Commissioner McCavic will assemble a Marina Water Committee to further review the issue.

2. Monthly Highlights - Andrea Klaas reported that she attended the Oregon Coastal Caucus Summit. Main topic was creating economic opportunities in rural communities; continuing to

pursue North Chenoweth funding ideas, DEQ, EDA, TIGER; the Commission is registered for the Oregon Public Ports meeting September 26-27 in Hood River; Oregon Economic Development Association Annual meeting will be in Hood River October 21-22; Mary Merrill is retiring the end of this year, her energy and tenacity will be missed in the community.

- 3. Development Update: Michael Held reported on a meeting with Chuck Covert And Rolf Anderson to get up to speed on various construction projects at the airport; submitted grant request of \$7,500 to Dept. of Land Conservation & Development for wetland Regional General Permit; we got the \$10,000 grant from Oregon Investment Board; RFP for the project is completed in draft form; Public notice for comments on draft findings of procurement policies went out Sept 12<sup>th</sup> and will close on Sept 26, 2013 at a Port Commission Special Meeting scheduled for noon at the Port office; North Chenoweth project is to be bid on October 1<sup>st</sup>, 2013.
- 4. Marina Update: Kathy Norton not at the meeting. Annual Marina BBQ was Sept 17, 2013; the Sea Lion is still at the Marina; Water system issues; City of The Dalles agreed to waive the excess water usage bill from the May Marina water bill with the understanding that a new system be installed within 120 days; 10 boathouses currently for sale, 2 other recent sales; open boat moorage space available at the Marina.
