#### **2021 YEAR IN REVIEW**

# **January**

- ➤ Interactive GIS mapping of Port District developed by RARE Anna Shank-Root
- ➤ Gorge Commission: Port and County filed a request for review of the Gorge Commission Management Plan in the Oregon Court of Appeals
- Oregon Food Bank bought The Dalles Leasing Company building located on Crate's Way
- ➤ Brownfield's coalition group (Port, City of The Dalles, Wasco County EDC) received \$600,000 from the US Environmental Protection Agency that will be used to help cover the costs of clean-up and building reuse projects over the next 3 years.
- ➤ Due to COVID-19, continued distributing PPE received from The Dalles Area Chamber of Commerce to Port businesses and Dufur
- SDAO Annual Conference was virtual
- 2020-2021 Work Plan finalized

#### **February**

- ➤ Dr. John Willer appointed to Budget Committee Position #3
- ➤ Port began work with MCEDD, CGCC, and State partners around a strategy to encourage tech businesses in our community through the Center of Rural Innovation (CORI), a project that was funded by Google.
- Began updating and migrating Port's website
- > Fielded calls from individuals wanting to start crypto mining companies in The Dalles
- ➤ RARE participant writes Travel Oregon grant for upgrades to directional signs and walking maps at the marina launch ramp

#### March

- ➤ Many conversations about whether The Dalles, and other communities on the Columbia River, would allow cruise ships to dock. Confusion because the Coast Guard was letting each community develop their own guidelines. In The Dalles we typically have 140 cruise ships docking over the summer.
- > Community Outreach Team met with Washington D.C. legislators and agencies via video conferences
- Spec building completed on Klindt Drive. Two apartments upstairs, business space downstairs.
- ➤ Dirt Hugger (started in Port went to Washington retail component now back in The Dalles)

➤ Houseless encampments pop up on Port property; work with The Dalles City Police and Northern Wasco County Parks and Recreation district to clean up.

# **April**

- ➤ MCEDD & the Port partnering with Google and the CORI to do economic development planning and opportunity analysis in The Dalles and Wasco County: focusing on technology job opportunities and entrepreneurship
- ➤ During COVID entrepreneurship is booming. How do we support that?

# May

- ➤ Adopted Fiscal Year Budget 2021-2022
- > Approved The Dalles Marina Second Amendment to Concession Agreement
- Approved amendment to The Dalles Marina Rules & Regulations
- ➤ Construction to start at 3761 Klindt Drive zoned commercial/recreation
- ➤ Travel Oregon Competitive Grant awarded \$45,230 to improve wayfinding from the Marina to downtown and do some infrastructure improvements to the launch ramp and parking lot area
- Pike-minnow Season began

- ➤ Meeting held in Dufur Community Partners Presented:

# <u>July</u>

- Marina Fire, July 3rd, 11:56pm: 8 boathouses burned, 5 boats burned, 4 of them sank. 5 boats were saved and moored in Transient Guest Moorage
- Gorge Commission legal counsel for the County, Port and CRGC have been talking there may be a path forward outside of the court of appeals process
- ➤ COT: New chair Scott Hege, Wasco County Commission Chair. Refocus effort: What are the community's biggest challenges?

# **September**

- Marina Fire (cont.): Engaged Northwest Maritime Marine Consultant
- ➤ Gorge Commission: Wasco County & Port have agreed to enter a mediation process and pause the legal process. The County and Port met to develop a strategy for the conversation around two areas: 1) the definition of minor expansion, and 2) how do bridgehead communities like The Dalles/Dallesport, Hood River/Bingen, and Cascade Locks /Stevenson address growth
- Launch Ramp Restroom Sewer backup repair needed
- > Wayfinding Signs (under Travel Oregon Grant) installed at The Dalles Marina
- ➤ Tree Clear Cut on Riverfront Trail near Klindt Cove Park
- Port Office: new energy saving windows installed and building painted
- Staff met with Captain Carrico of City of The Dalles Police, to talk about homeless and vagrant issues in the Port area. Similar issues are happening all over the City; staff will be working closely with him on any issues that arise.

- ➤ ED Klaas met with Mayor Mays to discuss ways the Port and City can combine forces and work together.
