RESOLUTION 22-005

PORT OF THE DALLES COMMISSION

A RESOLUTION DECLARING AN EMERGENCY AND AN EXEMPTION FROM COMPETITIVE BIDDING FOR CONSULTATION, CONTAINMENT AND CLEANUP ACTIVITIES REGARDING THE DALLES MARINA

WHEREAS, on August 1, 2022 in the early evening, a fire occurred on Finger B of The Dalles Marina ("Marina").

WHEREAS, The Port of The Dalles owns the Marina.

WHEREAS, the fire burned boathouses and their contents to the waterline.

WHEREAS, the destruction of the boat houses has caused burned construction materials and household materials, including plastics, cleaning products, paint/stains, boat maintenance chemicals, batteries, gasoline, and damaged fuel containers, to fall into the waters of the Marina.

WHEREAS, DEQ has directed that the Port take containment and cleanup action to prevent the spread of the spill to public waters, groundwater or soils beyond the original spill site.

WHEREAS, OAR 340-142-0030 requires that the "person owning or having control over the oil or hazardous material" must "undertake every reasonable method to stop the spill and contain the oil or hazardous materials," "arrange for properly trained and equipped personnel or contractor to stop any continuing release and manage the specific material spilled," and "must clean up the spill or release, and take steps to mitigate any threatened spill or release of oil or hazardous materials."

WHEREAS, The Port of The Dalles retained Advanced Underwater Systems to provide the initial consultation, containment and its ongoing measures as may be needed.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. The Port of The Dalles approves and adopts the attached Findings in Support of this Resolution.

Section 2. The Port of The Dalles hereby declares that emergency circumstances exist that require prompt execution of a public contract for emergency consulting, containment and cleanup, salvage, and disposal work for the cleanup of the Marina. The fire has caused an emergency condition that may result in the release of petroleum products and other hazardous materials into the waters of the Marina (the "Release"). The presence of these substances require an immediate response, containment and cleanup action by the Port of The Dalles.

Section 3. The Port of The Dalles finds that it may enter into public contracts for the consultant and contractor without competitive bidding because it has been ordered to contain and clean up oil or hazardous waste pursuant to the authority granted the DEQ and this order necessitates the prompt establishment and performance of the contracts in order to comply with the statues regarding containment and cleanup of spill or release of oil or hazardous materials.

Section 4. The emergency caused by the fire and Release requires the Port of The Dalles to immediately procure the services of a qualified contractor to perform the services of consultation, containment, cleanup, salvaging and disposal of the potential sources of the Release. The Port of The Dalles has selected per the Findings adopted hereby, the contractor, Advanced Underwater Systems as the contractor who is deemed best able to timely start and complete the required emergency work in an economical manner. The Port of The Dalles will negotiate directly with the selected contractor on the terms of the contract.

PORT OF THE DALLES COMMISSION SPECIAL MEETING (August 3, 2022) FINDINGS IN SUPPORT OF RESOLUTION NO. 22-005

(A)

Emergency Exemption from Competitive Bidding for Consultation, Containment and Cleanup in the Marina

(B)

Oil and Hazardous Materials Removal Exemption for Consultation, Containment and Cleanup in the Marina

General

ORS 279A.010 defines "emergency" as "circumstances that: (A) Could not have been reasonably foreseen; (B) Create a substantial risk of loss, damage or interruption of services or a substantial threat to property, public health, welfare or safety; and (C) Require prompt execution of a contract to remedy the condition."

ORS 279C.320 permits entering into contracts for emergency work in accordance with ORS 279B.080.

ORS 279B.080 permits Executive Director to make emergency procurements of services in an emergency.

The Port's Local Contract Board Rules established exceptions from competitive bidding, including:

Oil or Hazardous Material Removal. In situations where the Port is required by contract or by law, or when ordered by a court of governmental agency, to cleanup oil or hazardous waste, and the circumstances necessitate the prompt establishment and performance of the contract.

The Port's Local Contract Review Board rules provide in part:

Emergency Contracts. The Port of The Dalles may award public contracts without formal competitive bidding if the emergency conditions require prompt execution of the public contract in accordance with ORS 279B.080...... the Port of The Dalles may by resolution at a regular, special or emergency board meeting, declare the existence of any emergency that requires prompt execution of the contract.

The Port's Local Contract Review Board rules allow the Executive Director to declare the emergency for entering into contracts of initially \$50,000.00 or less and the Port Commission to declare the emergency by Resolutions for contracts over \$50,000.00.

Port's Local Contract Review Board rules also provide

Emergency Procurements

The Port Manager or the Port Manager's authorized designee may award a Public Contract as an Emergency Procurement, in an amount not to exceed \$100,000, using a procurement method that is practicable under the circumstances.

Port's Local Contract Review Board rules also provide:

(j) Oil or Hazardous Material Removal. The Port may enter into public contracts without competitive bidding when ordered to cleanup oil or hazardous waste pursuant to the authority granted the Department of Environmental Quality (DEQ)....and necessitating the prompt establishment and performance of the contract in order to comply with the statutes regarding spill or release of oil or hazardous materials.

2. The Fire and resulting damage prompting emergency action:

On August 1, 2022 in the early evening, a fire occurred on Finger B of the Port's Marina.

The fire burned boat houses and their contents to the waterline. The destruction of the boat houses has caused burned construction materials and household materials including plastics, cleaning products, paint/stains, boat maintenance chemicals, batteries, gasoline, and damaged fuel containers, to fall into the waters of the Marina.

The Port has received Oregon DEQ communication to contain, and remediate this environmental disaster.

The Port retained Advanced Underwater Systems to provide the initial consultation and containment. The Port worked with Advanced Underwater Systems in remediating the effects of the fire in the Marina on July 3, 2021 and knows its work to be excellent, its staff highly qualified and dedicated and its costs reasonable and competitive with any other available options. Costs are anticipated to be saved by acting quickly to get Advanced Underwater Systems into the water and disaster site at/in the Marina and helping the Port meet its statutory and legal obligations in these circumstances. Any delay in doing so would actually be costly and problematic. The Port administration has first hand knowledge of how to handle the issues caused by this fire with the help of a first class consultant and contractor like Advanced Underwater Systems (and aware and knowledgeable of other "such contractors" in the field) all based on first hand experience and knowledge emanating from last year's July Marina fire and its aftermath. Burnt construction

materials from the boat houses and their pre-fire contents continue to be in the waters of the Marina and on the floor of the Marina.

3. The Emergency:

The Port hereby declares that emergency circumstances exist that require prompt execution of a public contract for emergency consulting, containment and cleanup, salvage and disposal work. The fire has caused an emergency condition that resulted in the release of petroleum products and other materials into the waters of the Marina (the "Release"). The continued presence of these substances requires an immediate response and cleanup action by the Port.

The emergency caused by the fire requires the Port to immediately procure the services of a qualified consultant to act as the Port's representative in evaluating the containment and scope of cleanup, salvaging and disposal of potential sources of the Release.

The emergency caused by the fire requires the Port to immediately procure the services of a qualified consultant and contractor to perform the containment, cleanup, salvaging and disposal of the potential sources of the Release. Advanced Underwater Systems is able to immediately work on this contract and saves the Port substantial ongoing costs.

Immediately contracting with the proposed consultant and contractor are imperative to prevent any further releases, to quickly cleanup the Marina, to protect nearby recreational locations and activities, to protect public health, to end as quickly as possible the substantial daily costs of containment, to preserve the Port's limited financial resources.

The Oil Spill and Hazardous Material Cleanup:

The Port finds that it may enter into public contracts for the consultant and contractor without competitive bidding because it has been ordered to clean up oil or hazardous waste by the DEQ necessitating the prompt establishment and performance of the contracts in order to comply with the statutes regarding spill or release of oil or hazardous materials.

The Dalles Marina

- Fire 08-01-2022 Update
 - o Port Staff worked with Special Districts to maximize available coverage to the Port. We believe that our expenses will come in below our insurance limits.
 - o Portable office and toilet/wash area were removed.
 - o The cleanup was turned over to The Dalles Marina, LLC starting September 6th.
 - o There were challenges getting on contractor's schedules to do the cleanup, but as of 09/08/2022 we understand cleanup will begin the end of this week/early next week.
 - o Material may be off-loaded at Bernert Barge Lines then hauled to Wasco County Landfill.
 - We are working in conjunction with The Dalles Marina, LLC to return the marina to normal operations as soon as possible.
 - o The public boat launch remains open.
- ➤ Pikeminnow catches are tapering off as the season winds down. The Dalles basin shows 19,761 total caught this year, but August's total catch was only 177. 2021 yearly total catch was 10,058, so a substantial increase. The top angler in Oregon has received a payout of \$50,210 by catching 4,976 fish!
- ➤ Small, local business Get 'er Done continues to maintain the Marina Parking Lot, Launch Ramp, Jetty's & Transient Guest Moorage, keeping the area free of garbage and clean, and North Wasco County Parks & Recreation does the same for the restrooms.

Business Inquiries

- New State Leads:
 - o Project Green Fuel: Green hydrogen and ammonia plant. 177 acres. Will employ 500 people.
 - o Project Stamper: Aviation manufacturing. 600,000 square foot building. 1,200 employees
- Other Leads:
 - o Yurt company looking for a Pacific Northwest location on a good transportation corridor.
 - Wood products company looking for a location to process lumber.
 - o Oregon-China company wants to lease land (then potentially purchase) for their crypto-currency business.

Center for Rural Innovation: The Dalles Technology Center

- MCEDD has hired a coordinator for this program, Kristyn Fix, through a grant from Business Oregon.
- Next event will take place in Maupin, Oregon on September 24th.

Brownfield Coalition Update

- No new information on this, other than to say that it has been quite successful.
- ➤ There are 9 properties, with 12 projects that are projected to be completed by the end of the year. Project types are: Phase I Environmental Assessment Survey (1), Phase II Environmental Assessment Survey (6), seismic evaluation (1), Regulated Building Materials survey (4)
- ➤ All \$600,000.00 of the Environmental Protection Agency (EPA) grant funds have been committed.
- ➤ The coalition is still reviewing applications and adding them to queue, but with the caveat that the project will happen if there are funds available.
- > Due to the very strong response to this program the City of The Dalles is working with the EPA to apply for additional grant dollars

Other

- Old Port GMC truck was driven in the Dufur Threshing Bee Parade. Thanks to Tim McGlothlin for driving, and Commissioner Wallace for picking up the truck in The Dalles and delivering it to Dufur.
- ➤ Local business Meadow Outdoor Advertising was listed #63 on the Oregon Business 100 Best Green Workplaces in Oregon 2022! Oregon Business 2022 100 Best Green Workplaces in Oregon
- ➤ President Weast and ED Klaas met with Dan Spatz, Director, Capital Projects and Community Relations, Columbia Gorge Community College, to learn more about a childcare proposal that the college is drafting. Spatz is hoping to create a childcare coalition to discuss ways to tackle this problem. The college has some funds available to get a program started, but they are projecting a \$200,000/year operating shortfall and would like to do a feasibility study to better understand what kind of subsidy is needed and how many enrolled children are needed to break even.
- ➤ The Port has applied for a safety grant through Special Districts. Our projects are: install additional security cameras at the Port Office; work with Salvos Training to develop a defense plan for the office and also do some self-defense training.
- ➤ ED Klaas met with Katie Franko, Public Affairs. The discussion focused on how Google can help support the CORI/Innovator efforts happening in The Dalles.
- ➤ ED Klaas, Tyler Stone, Chief Administrative Officer, Wasco County, and Wasco County Commissioner Hege, met with two representatives from Lockheed Martin to discuss ways Lockheed Martin and the community can work together on projects.
- Power Engineers will be moving on to property on River Trail Way the beginning of October.
- ➤ The City of The Dalles has moved off Lot 10 and that lease has ended.
